- LATE FEES: Invoices not paid within 30 days will be assessed a \$25 late fee and account will not be extended credit until a significant portion of the balance is paid before further advertising is accepted.
- RETURN FEES: Declined Credit Card will be assessed a \$10 fee. Returned Check Fee will be assessed a \$25 fee.
- **LOCATION PRINT PREMIUM FEE:** Online Side Box Ads are not guaranteed a particular space in the Pioneer Website unless a 25% premium charge on top of the total ad cost is applied and the space is not already taken.
